- Whereas* Over half a million settlers live in the settlements, with gangs daily attacking Palestinians, destroying their crops, and with the help of the Israeli army, destroying their homes for further settlement expansion, and
- Whereas* Ben & Jerry's Israeli franchise is selling ice cream in supermarkets and catering affairs in these illegal, Jewish-only settlements, and
- Whereas* Ben & Jerry's famous social mission "seeks to meet human needs and eliminate injustices in our local, national and international communities"
- Therefore* We find Ben & Jerry's in this matter to be in gross violation of their corporate mission statement, and
- Therefore* **We demand that Ben & Jerry's immediately cease sales and activities in illegal Israeli settlements in Occupied Palestine.**


